Subject: Persistent Threats and Harassment Against a Member of Parliament

Dear Mr. President,

I write to you today with a heavy heart and grave concern regarding the persistent threats to my life and the constant harassment I have been enduring for the past year. As a Member of Parliament, my primary responsibility is to represent the interests and needs of the Somali people. To this end, I have been planning to return to Mogadishu to bring forward three critical motions before the House of the People:

1. **Motion to Protect Internally Displaced Persons (IDPs):** This motion seeks to address the illegal eviction of IDPs during the civil war, drought, and flooding, as well as ongoing civil conflicts between tribes. It aims to stop the Federal Republic of Somalia government from selling land to businessmen connected with Villa Somalia.
2. **Motion to Regulate International Agencies and NGOs:** This motion proposes that all international agencies, donors, and NGOs operating in Somalia conduct their business within Mogadishu. Failure to comply would result in the revocation of their certification to operate within Somalia.
3. **Motion to Increase Salaries and Benefits for Security Forces:** This motion advocates for an increase in salaries and benefits for our National Defense Forces, National Police Forces, National Correctional Forces, and National Intelligence and Security Agency officers and their families. This initiative is crucial to boosting the morale and effectiveness of these forces in defending our country.

Mr. President, I have the full support of my colleagues in the House of the People in turning these motions into reality despite any potential presidential veto. I am planning to discuss with my colleagues in detail how we can achieve these goals that will benefit the Somali people. I am also planning to attend numerous public forums and debate about the many issues and problems that our country is facing, especially in the **areas of rule of law, justice, corruption, transparency, governance, human rights, and freedom of speech**. I have been invited to engage directly with Somali citizens in face-to-face discussion forums to listen to their concerns and issues they face every day so that we can bring these issues to the floor of the House of the People and conduct hearings by calling concerned agencies and their leadership. It is our responsibility to have full oversight of all agencies, so they are accountable to the Somali people.

Mr. President, unfortunately my efforts to serve the Somali people have been met with **severe resistance, harassment, threats, intimidation, and insults**. Since last year, and worsening over the past three months, I have been subjected to numerous threats, including **threats to my life, harassment, and intimidation**. **I have reported these threats to the Inter-Parliamentary Union (IPU), International Criminal Court (ICC), United Nations, embassies in Somalia, and the FBI and Justice Department, and other International Security Agencies**.

Mr. President, most recently, following my announcement to attend the upcoming parliament session in Mogadishu, **I have received increased harassment and threats of prosecution and intimidation from Villa Somalia advisors.** This hostile environment has forced me to postpone and forfeit my airfare for the planned trip back to **Mogadishu on Wednesday, July 10, 2024.** Despite sharing my travel schedule openly, I have been advised by my security experts to postpone my trip indefinitely due to the highly dangerous security environment in Mogadishu. My extensive oversight investigations uncovering rampant corruption within various federal government agencies, including Villa Somalia, the Prime Minister's office, and international donor-funded projects, and my intensive schedule to attend and participate in many forums, debates, and hearings is highly dangerous.

Mr. President, **it is with profound disappointment that I note the failure of your office, the Prime Minister, the Speaker of the House of the People, the Minister of Internal Security, the Head of National Police, and the Head of the National Intelligence and Security Agency to provide adequate security for all members of parliament regardless of their political leaning or their oversight work.** This failure has emboldened individuals within your administration and business interest groups to threaten MPs who do not align with their political narratives, or whose oversight investigations reveal their rampant corruption. **It appears that some in your inner circle and business interest groups believe they are above the law, disregarding the clear responsibilities outlined in the Somali Constitution.**

Mr. President, **after consulting with my security experts, who possess extensive experience, I have decided to heed their advice and postpone my trip.** They have assessed that my safety in Mogadishu during parliamentary sessions and my intensive schedule to attend and participate in many forums, debates, and hearings cannot be guaranteed. The information they have collected indicates a 99% likelihood that my security would be compromised.

Mr. President, **I urgently request that you and the Prime Minister publicly condemn, in the strongest possible terms, any threats or acts of violence against MPs.** **It is imperative that your administration makes it unequivocally clear that such actions are unacceptable and that anyone threatening a member of parliament will be prosecuted to the fullest extent**

of the law. Additionally, I request that you ensure my safety and recall the importance of respecting parliamentary immunity and privilege.

Mr. President, I am expecting you to take the lead in making a public statement. Failure to do so will only encourage further threats against MPs who do not subscribe to the administration's views, undermining our democratic process and the rule of law. Therefore, I cannot in good conscience and sound mind travel to Mogadishu until you and the Prime Minister order the Minister of Internal Security, the Commander of National Police Forces, and the Director General of National Intelligence and Security Agency to provide me full security during all my activities in Mogadishu. If any harm happens to me during this period, you and the Prime Minister will take full responsibility. Your silence on my request is equivalent to negligence of the oath you took for all citizens of the Federal Republic of Somalia, and silence is not an option.

I want to assure the Somali people that I remain committed to my duties and responsibilities as a member of the House of the People and will continue to conduct oversight investigations into all agencies, irrespective of who leads them.
