### **Jawaabta Hadalka Been Abuurka ah ee Wasiirka Maaliyadda ee Shirka Warbixinta Maamulka Maaliyadda Soomaaliya 2023**

Iyada oo aan ka jawaabay hadalka uu maanta ka jeediyay Wasiirka Maaliyadda **Shirka Warbixinta Maamulka Maaliyadda Soomaaliya 2023 ee ka dhacay Hoteelka Decale, waxa muhiim ah inaan wax ka sheegaa warbixin Been Abuur ah ee uu ka hor sheegay hortiisa Mudane Ra'iisul Wasaaraha Jamhuuriyadda Federaalka Soomaaliya, martida caalamiga ah, saraakiisha Soomaaliyeed, iyo bulshada ganacsiga.** Wasiirku si been ah ayuu u soo bandhigay waxyaabaha ku jira emailka aan ka helay **Mudane Pdraig Power, Madaxa Maaliyadda ee Ururka Global Partnership for Education (GPE), taariikhdu aheed Juun 1, 2024.** Emailkani wuxuu ahaa jawaabta warqaddayda rasmiga ah ee aan u diray **GPE** iyo **Save the Children**, oo aan ku soo bandhigay arrimo dhowr ah oo muhiim ah:

- 1. Faragelinta Arrimaha Waxbarashada ee Dowladaha Xubnaha Federaalka:** Wasiirka Waxbarashada, Hidaha, iyo Tacliinta Sare ee Dowladda Federaalka Soomaaliya ayaa faragelin ku haya arrimaha gudaha ee nidaamka waxbarashada ee Dowladaha Xubnaha Federaalka, taas oo ka hor imaaneysa **Qodobbada Qabyo-qoraalka Dastuurka ee 52 iyo 54.** Lacagaha loo qoondeeyay **Somaliland** waa in loo wareejiyaa qaybta **SSC** Wasaaradda Waxbarashada ee **SSC**. Intaa waxaa dheer, magaca **Somaliland** ee ku qoran bogga internetka waa in la tirtiro.
- 2. Isku Dhaca Danaha:** Milkiilnimada Wasiirka Waxbarashada ee iskuullada hoose iyo sare iyo jaamacadaha Muqdisho waxay la macno tahay isku dhac danaha. Waxaan ku booriyay **GPE** inay ka codsadaan

Wasiirka Waxbarashada inuu ka fogaado go'aan ka gaarista mashruucan.

3. **Musuqmaasuqa Qandaraasyada:** Waxaa jira musuqmaasuq baahsan oo ku saabsan habka qandaraasyada ee mashruuca. Waxaan soo jeediyay in hababkaas ay maamulaan Dowladaha Xubnaha Federaalka halkii Wasiirka Waxbarashada ee Dowladda Federaalka.
4. **Tallaabooyinka Ka-hortagga Musuqmaasuqa:** Waxaan ku adkeeyay baahida loo qabo la dagaallanka musuqmaasuqa iyo dhisidda nidaam kormeer oo loo xilsaaray **GPE** iyo shacabka Soomaaliyeed.

**GPE** waxay si sharaf leh uga jawaabtay, iyada oo tixgelinaysa dhammaan walaacayga iyo xaqiijinaysa siyaasaddooda **EBER-U-DULQAAD** la'aanta ee ku aaddan lunsashada lacagaha, iyadoo si adag ugu heellan waxbarashada carruurta Soomaaliyeed ee dhammaan Dowladaha Xubnaha Federaalka.

Nasiibdarro, Wasiirka Maaliyadda, oo aan wax shaqo ah ku lahayn arrimaha waxbarashada, wuxuu doortay inuu si khaldan u soo bandhigo emailkani shacabka hortiisa halkii uu ka hadli lahaa musuqmaasuqa baahsan iyo karti la'aanta ka jirta wasaaraddiisa. Emailka **GPE**, oo aan hadda soo bandhigay, looma soo dirin mana loo qorin Wasiirka Maaliyadda, taas oo muujinaysa sida qaladka ee uu u sheegay dadka hortooda.


Wasiirka Maaliyadda oo diiday inuu igu magacaabo magacayga iyo xilkayga sida Xildhibaan, halkii uu iga sheegayay si meel-ka-dhac ah, waxay muujinaysaa sida uu uga dhega adeegay habraacyada saxda ah iyo nidaamka baarlamaanka. Edeymaha asaas la'aanta ah waxay u muuqdaan inay yihiin isku day uu ku weecinayo baaritaanada ba'an ee aan sameeyay labadii sano ee la soo dhaafay—baaritaano oo si cad u taabtay nabar isagoo ku guuldareystay inuu ka jawaabo in ka badan 65 warqadood oo rasmi ah oo aan u diray.

Gebagebadii, waxaan ku boorinayaa shacabka iyo dhammaan daneeyayaasha inay dib u eegaan emailka **GPE** oo ay kala gartaan xaqiiqda iyo mala-awaalka siyaasadeed. Waa nasiib darro in Wasiirka Maaliyadda uu

doortay goobtan inuu isku dayo inuu iska difaaco halkii uu ka hadli lahaa arrimaha muhiimka ah ee uu mas'uulka ka yahay.

Waxaan u rajaynayaa Wasiirka Maaliyadda wanaag iyo rajo ah inuu mustaqbalka ka jawaabo dhammaan waraaqahayga baaritaanka ee aan ku sameeyay.

Dear Honorable Member of Parliament, Dr. Abdillahi Hashi Abib,

We acknowledge receipt of your letter dated May 27, 2024, regarding concerns related to the implementation of the Global Partnership for Education (GPE) program in Somalia, as well as your reply dated May 30 to the response from GPE grant agent Save the Children also dated May 30.


Allow us to briefly respond to your concerns.

1. As is the case in all federal countries, the Federal Government of Somalia is the primary interlocutor for GPE's engagement, and we seek within the country's constitutional system guidance on how to work with different states. GPE Secretariat has received assurances from the Federal Minister of Education that your letter will be addressed by government through the appropriate parliamentary channels.
2. The allegation that the Federal Minister of Education holds shares in private education institutions and thus is in a potential conflict of interest, is noted. However, as no GPE funds can benefit private for-profit education institutions, this is not something of direct concern to GPE.
3. GPE grant agent Save the Children has already responded concerning program governance, fiduciary matters and procurement on the GPE-funded system transformation grant (STG) program, per its mandate. We reiterate the key point that no procurement has yet taken place on the STG programs approved in 2024, as the program has in fact yet to start implementation, hence no awards have been awarded to any company yet.
4. GPE has zero tolerance for misuse of funds. Partners use their own policies and procedures to address misuse cases and secure recovery of GPE resources. The GPE Secretariat carefully monitors misuse cases with the relevant grant agents to ensure that all cases are properly addressed. The GPE Secretariat also facilitates reporting of misuse cases to the GPE Board and the Finance and Risk Committee. To report suspected cases of fraud in GPE-funded programs, we refer you to kindly contact the appropriate grant agent, in this case Save the Children and CARE.
